

**Gateway Metro Federal Credit Union
Solo Stove Bonfire Sweepstakes**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: Sweepstakes (the “Sweepstakes”) is open only to those who sign up at the online sweepstakes page and who are at least 18 years of age as of the date of entry. The sweepstakes is only open to legal residents of the contiguous United States and is void where prohibited by law. Employees, Committee Members & Board Members of Gateway Metro Federal Credit Union (the “Sponsor”) their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

3. Sweepstakes Period: Entries will be accepted online starting on or about **September 1, 2021** and ending **September 25, 2021** All online entries must be received by **September 25, 2021 11:59PM CST**.

4. How to Enter: There are three ways to enter this sweepstakes. You may submit one entry using the online form provided on this Sweepstakes site. All information is required to be considered complete. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Gateway Metro Federal Credit Union. You may enter only once online and you must fill

in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of Gateway Metro Federal Credit Union. You may enter in person on September 25th at our community shred event at 840 Meramec Station Rd, Twin Oaks, MO. One entry can be made using a form or QR code at that location. Up to one additional entry may be earned from the prize wheel on display at that same event. You may enter by completing the entry blank mailed to individuals around the branch location and returning that on the day of the event when you present items for shred. The maximum number of entries any one person may have is four.

5. Prizes: Winners will receive a Solo Stove Bonfire with an approximate retail value of \$250.00. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is non-transferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted. Acceptance of prize constitutes permission for Gateway Metro Federal Credit Union to use winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner selection and notification: Winners of the Sweepstakes will be selected in a random drawing under the supervision of the Sponsor. Winners will be notified via email to the email address they entered the Sweepstakes with within five (5) days following the winner selection. Gateway Metro Federal Credit Union shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning

contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.

The receipt by winner of the prize offered in this Sweepstakes is conditioned upon compliance with any and all federal and state laws and regulations. Gateway Metro Federal Credit Union reserves the right at its sole discretion to disqualify any individual who tampers or
